## P&V Holdings Joins Japan Animal Care Holdings through Strategic Capital Alliance

Japan Animal Care Holdings Inc. ("JPAC"), which is indirectly owned by funds managed by Integral Corporation and its affiliates through a holding company ("HD"), has entered into a strategic capital alliance with P&V Holdings Co., Ltd. ("P&V"). P&V is a veterinary hospital group operating four clinics primarily in the Kansai region.

P&V was established in 2022, centered around Uehommachi Animal Hospital in Tennoji-ku, Osaka, which provides "1.5 primary care" services focusing on dogs and cats under the medical philosophy of "Practicing Evidence-Based Medicine (EBM)". The group has achieved consistent growth, with Sotobo Animal Hospital (Chiba Prefecture) and Yagura Animal Hospital (Wakayama Prefecture) joining in March 2025, followed by Kawachi Animal Hospital (Osaka Prefecture) in June 2025. After the alliance with JPAC, each hospital will continue to contribute to local veterinary care under their existing clinical policies.

With the addition of P&V, the group—centered around the HD which also oversees JPAC and ANCHORS—has expanded to a total of 41 facilities (40 veterinary hospitals and 1 laboratory) across 13 prefectures. Integral Corporation will continue to support the business operations and further growth of each company by providing its accumulated management expertise, the "i-Engine" on-site support function, and its extensive professional network.
